Annual Hospice Symposium: The Importance of Early Conversations About Hospice Care

Early education and open communication are critical to maintaining or improving quality of life, especially as a loved one nears the end of life. Hospice care, available for patients with a life expectancy of six months or less, focuses on comfort and support for both the patient and their family.

On October 5, Kurt Kazanowski—hospice consultant, speaker, author, and coach—shared his expertise on initiating these conversations early. Drawing from his personal experiences with his aging parents and his extensive work as a nurse and hospice professional, Kazanowski provided practical advice and heartfelt insights. His presentation empowered attendees to navigate these challenging discussions and highlighted how hospice care can be a meaningful gift for loved ones.



Fuel vouchers help patients and their families who demonstrate financial need to travel to and from Trinity Health's CancerCare Center to receive their treatment. Nearly 36% of the patients treated at Trinity Health's CancerCare Center travel over 150 miles for each treatment.

6th Annual Fuel the Fight Raises Over \$84,000

Trinity Health Foundation partnered with Dakota Square Arco and other businesses on September 9, to "Fuel the Fight" against cancer. Fuel the Fight supporters stopped by Dakota Square Arco throughout the day to fill their gas tanks and the fuel voucher fund. Anyone purchasing eight gallons or more of fuel was registered to win a year of free gas, courtesy of First International Bank & Trust. Fuel the Fight helps support the fuel voucher program offered to patients receiving care at Trinity Health's CancerCare Center. Patients receiving active oncology-related treatment are eligible for up to four \$75 vouchers annually for a total assistance of up to \$300.

INVESTMENTS IN THE FUTURE

Nursing Scholarships

Awarded 17 scholarships to nursing students throughout the region. In total, the Trinity Health Foundation has awarded \$331,300 scholarships to 106 nursing students in the last seven years. This year we added a nursing scholarship to Minot High HOSA students who are interested in pursuing a degree in nursing. \$1,000 scholarships were awarded to: Isabelle Anderson, Emma Rensvold, Alexa Rice and Morgan Strange.



Radiologic Technology Scholarship

The Michelle Keller Rad Tech scholarship is open to senior students in the Trinity Health School of Radiologic Technology. Each year senior radiologic technology students prepare scientific research papers, that are judged anonymously, to compete for the scholarship. The 2023 Michelle Keller Rad Tech Scholarship Winner is Abigail Richardson for her research paper on Psychoradiology.



Minot Chapter of HOSA (Future Health Professionals)

Trinity Health Foundation is proud to invest in our community by supporting Minot High School's Health Occupations Students of America (HOSA). We granted \$10,000 to assist HOSA students attending the 2024 International Leadership Conference in Houston, TX.

INVESTMENTS IN TRINITY HEALTH STAFF

GRACE

Fund allows staff members to assist their co-workers by designating a portion of their paychecks to be gifted to Trinity Health employees facing a hardship situation for themselves or an immediate family member. Funding was awarded to 22 staff members for over \$60,000.

Education and Training

Assists in providing funding for staff to participate in educational activities, conferences and training opportunities including LPN IV certification class, Trauma Quality improvement program conference and the Minnesota-Dakota Society of perianesthesia nurses winter conference.







INVESTMENTS IN TRINITY HEALTH EQUIPMENT

Pediatric Therapy Gym

Thanks to support from Town & Country Credit Union, Trinity Health Foundation supported a new Pediatric Therapy Gym at Trinity Health West. The gym provides vital therapeutic care for children with developmental disabilities. Key Features – Sensory Gym: Designed for safe, engaging play and sensory stimulation. Two Calming Rooms: Stress-free spaces for relaxation and focus. Therapy Services: Physical, occupational and speech therapy available. Skill Development: Enhances core strength, sensory processing and social interaction.

Infusion Chairs

Thanks to a generous donation from Roger & Adeline Evans, Trinity Health Foundation was able to replace eighteen infusion chairs at the Trinity Health CancerCare Center.

Glidescope Go

Four GlideScope Go video laryngoscopes were purchased by the Trinity Health Foundation for First Response Ground Ambulance. The GlideScope Go is a medical device that helps staff see inside the throat to place a breathing tube safely. It has a tiny camera at the tip allowing the user to see the airway on a screen, making it easier to guide the breathing tube into the right place.

GRANTS

Hess – Granted \$50,000 toward the purchase of a new 4x4 ambulance for Trinity Health's First Response Ground Ambulance service.

American Cancer Society – Granted \$10,000 to assist cancer patients with costs associated with traveling to and from treatment.

Rural Community Grant Fund – Granted \$25,000 toward the completion of a training/conference room for Trinity Health Western Dakota Clinic in Williston.

Minot Area Community Foundation – Granted over \$15,000 to purchase necessary equipment for Trinity Health's Focused Exercise – Parkinson's

North Dakota Department of Commerce Regional Workforce Impact Program – Granted over \$245,000 to purchase training equipment and upgrade audio/visual capabilities to improve and expand training programs for both current and future Trinity Health RNs, CNAs and EMS professionals.




